Transfer Connections

The Transfer Connections program streamlines the steps toward a bachelor's degree. There are two options within the program; 1) advising as you complete your associate's degree or 2) participation in *Dual Admissions* and advising as you complete your associate's degree. Either way, you will work directly with the Transfer Connections Coach as early as possible while at North Shore Community College, to ensure a smooth transition from the associate's degree to the bachelor's degree.

Dual Admission

Upon admission to NSCC, if you opt-in via the NSCC application, you will simultaneously be admitted to SSU and matriculated upon graduation from NSCC if you meet the criteria specified below.

If you join Transfer Connections later in your program at North Shore, you may still be eligible and benefit from Dual Admissions, depending on courses taken prior to participation in the program.

If for example, you join Transfer Connections in your final year or semester at North Shore Community College and you had taken courses that may not have necessarily been the most optimal / applicable to your chosen major at Salem State University following transfer you are still eligible to participate in Transfer Connections, but possibly not the Dual Admissions aspect specifically. In this case, you will still benefit from advising, but will apply to Salem State University via the regular Admissions process, under the terms of the Mass Transfer policy wherever applicable.

The Transfer Connections Coach will determine if you are eligible for and if Dual Admissions makes sense for you.

Eligibility for Dual Admissions

Dual Admission between North Shore Community College and Salem State University is contingent upon successfully completing the outlined associate's degree program and meeting the required cumulative college-level GPA.

At the beginning of your final semester at North Shore Community College, it is required to have your official North Shore Community College transcript submitted to admissions for Dual Admission eligibility review. A final transcript will be required once you enroll at Salem State University.

If, between now, and your future transfer to Salem State University, your contact information changes, please contact admissions@salemstate.edu to update your file.

If you change your major while attending North Shore Community College or Salem State, it is no longer *guaranteed* that all credits will *apply* to your degree program. If you wish to change your major, contact the Transfer Connections Coach for guidance on how this may affect Dual Admission eligibility or the applicability of transfer credit. Please note that we will honor the admissions requirements outlined above, except when external licensure or accreditation requirements dictate a change in requirements. In those cases, we will do our best to communicate any changes as soon as they occur and revise your plan.

If at any point you complete college-level work outside of North Shore Community College, you will need to provide an official transcript from that college or university. If you attend another college or university as a degree-seeking student <u>after</u> attending North Shore Community College, Dual Admission will be void, and you must reapply to Salem State University.

If making any changes to the above agreement, please schedule an appointment with your Transfer Connections Coach to submit a new Dual Admission Participation Form.
